## 2014/2015 Fees and Charges for Community Halls and Arts Facilities - Report from the Orakei Local Board Chairperson

### Purpose

1. Reconsideration of the Orakei Local Board resolution to change the fees and charges for community halls and arts facilities for 2014/2015.

### Executive summary

2. Standing Order 3.10.17 provides for a resolution to be revoked on the basis of a recommendation in the report from the Chairperson. I am seeking reconsideration of the Orakei Local Board resolution, made at its meeting on 17 April 2014, which increased the fees and charges for community halls and arts facilities. The attachment in the report referring to the fees and charges for 2014/2015 was not the same attachment agreed to by the Board at an earlier workshop.

### Recommendation/s

That the Orākei Local Board:
