  - v. Kauri Carnival \$18,750 subject to satisfactory scoping of the event being brought back to a workshop for development, and reported to a local board meeting for approval.

- e) Notes that the Waitakere Ranges Heritage Area gateway signage project listed in Category 3 (Attachment A) will be consulted on through the draft Waitakere Ranges Visitor Management Plan.
