Special economic zones – what are they and can they help regional New Zealand?

This Masterclass will define what a Special Economic Zone is, highlight characteristics of both successful and unsuccessful cases, explore potent benefits and pitfalls for their use in New Zealand and hear what some councils would like to see incorporated into a trial zone.

Collaborative processes and decision-making

This Masterclass will explore what collaborative processes mean for traditional local government decision-making in the management of natural resources and what the scope is to apply collaborative processes to other issues. It will also explore the interaction with treaty settlement and what some of the expectations of iwi in relation to collaborative processes.

Resilient towns, cities and regions – creating places for the future

Join Jeb Brugmann, Founder of ICLEI - Local Governments for Sustainability, for this masterclass to take a deeper look at how to approach resilience as a new category of place-making performance and as an investment-worthy proposition.
