Summary	The overall project for Mutukuroa Hamlins Hill Regional Park is to fence off part of the grazed pasture and plant with natives to create a small urban forest with tracks, open spaces, and views across the city in accordance with the Concept Plan. Most of the fencing and initial pioneer/nurse planting has been done and now enrichment native planting, the purpose of this project, is required for a number of years. The number of years is dependent on the amount of funding that can be raised.		
Requesting grant for	Advancing the enrichment planting phase of the park plan. Native ecosourced plants are purchased from commercial nurseries, this being the most efficient means, and then grown on in the park nursery for 2 – 3 years to develop root mass and height to improve survivability when planted. The plants are of small size to reduce purchase costs. For some plants seed will have to be collected and propagated first by the local nurseries. Please note that the amount of funding sought represents only a part of the overall amount that will be required to complete the enrichment planting.
