Maori outcomes	Yes, Disability is an important issue for Maori, who have a relatively high disability rate for a population with a relatively young age structure. The 2013 Disability survey identified one in four Maori as disabled, the most common types of impairment being those related to mobility. Disabled Maori adults and children were less likely to participate in many popular leisure activities than their non-disabled peers. Indicators show that disabled Maori tend to have poorer outcomes than non-disabled Maori in terms of both material well-being and quality of life, with the material disparities being the most marked. At the Chariot Project all of our programmes are free. We will be consulting with local iwi on engagement with young Maori.
Accessible to disabled	Yes, The Chariot Project provides regular, ongoing and meaningful sports programmes and competitive sports leagues for young people with a physical disability. All volunteers and coaches have the necessary skills to train and support our young athletes. As this group of young people face many barriers to participation research has identified that access and availability of transport is the biggest barrier, we aim to make it as easy to participate as we can and offer assistance through our volunteers by picking up and dropping off the young people who would otherwise not be able to participate.

Summary	<p>The most highly regarded service of the Blind Foundation is the library which has over 10,000 titles in its collection. Last year 4650 users of this free service borrowed 616,410 items. Feedback anecdotally and via the library user survey consistently shows a high demand for more New Zealand titles, more topical subjects and more recently published books in a wide variety of genres. Access to books is a lifeline for people who have lost their sight and now have much more unstructured time available due to their inability to continue with sport, arts and hobbies and potentially their former employment.</p>

Requesting grant for	<p>While the Blind Foundation funds the library as a core operational service, the purchase of talking books is dependent upon funds raised. The Foundation applies to many trusts and local authorities across New Zealand seeking a contribution. Each donation enables the growth and currency of the national library collection, providing equitable access to a large repository of books for members of the community with low vision that the public library has limited ability to serve. Each book added to the permanent collection costs approximately \$500-1500 with multiple licences purchased allowing many concurrent borrowers of any popular title at one time.</p>
