	Local Board PPlan Feedback : Local Board Draft Plan: We are supportive of the Draft Local Board Plan with respect to the recognition and inclusion of Sport and Recreation as an outcome seeking to serve the needs of a significant portion of the community. Basketball is the fastest growing major sport in the North Harbour area and will become the largest school sport within the next five years. Along with other fast growing indoor sports of futsal, badminton and volleyball there is enormous pressure being placed on the inadequate number of indoor facilities in the North Harbour area. We strongly request that the Local Boards and Auckland Council immediately allocate resources to alleviate the urgent shortfall of indoor facilities in our area. The expansion of the North Shore Events Centre from four to eight courts will initially future proof the demand for indoor space from basketball, futsal, badminton and volleyball. We also request that indoor facilities be planned for the Local Board areas of Upper Harbour, Hibiscus and Bays ( Silverdale) and Rodney (Warkworth) as the populations expand in these areas.
