Report by the SOUL Delegation to Local Board Meeting 21 Feb 2018
Presented by Brendan Corbett and Delwyne Roberts on behalf of Save Our Unique Landscape (SOUL)



1. Introduction:

This report concerns SOUL's efforts to #ProtectIhumātao for future generations. The issues raised here correspond to planned outcomes, objectives and key initiatives stated in the 2017 Māngere-Ōtāhuhu Local Board plan, in particular:

Outcome 3: Protecting our natural environment and heritage.

Objective: Local heritage is protected, enhanced and recognised.

Key initiative: Identify further actions from the heritage survey of historic buildings and sites, for example, signage to explain our heritage.

Outcome 5: Facilities to meet diverse needs.

Objective: Existing facilities, parks and open spaces are high-quality, well maintained and are accessible to diverse users.

Key initiative: Fund enhanced maintenance for Otuataua Stonefields Historic Reserve.

All matters in this report are of high priority and we note areas requiring immediate attention. The report makes sad reading and failure to take action could reflect poorly on the Board. We are fast approaching confrontation on the land but doing everything we can to prevent it.

2. Political engagement – IMMEDIATE ACTION NEEDED

SOUL has requested a meeting on the land with the Prime Minister, Rt Hon Jacinda Adern, who has a portfolio responsibility for heritage matters, the Minister of Conservation, Hon. Eugiene Sage, and the Minister of Housing and Land Development, Hon Phil Twyford. We intend to invite the Deputy Prime Minister, Rt. Hon. Winston Peters, recognising that our parliament is constituted by a coalition government, and we hope the Minister of Māori Development, Hon. Nanaia Mahuta, will come along with others who have expressed interest. Our purpose is to discuss the crisis related to SHA62 and suggest a way forward in an attempt to create a process that will achieve an outcome all parties can live with and, importantly, avert a confrontation on the land. Our local MP, now a government minister, Hon. Aupito William Sio, has agreed to facilitate this meeting. He has stated he will stand in front of the bulldozers with his constituents, if necessary. We request Local Board representation at the meeting with Ministers, preferably the Chair. The problem is as much national and regional as it is local but strong local leadership is crucial to a successful outcome.

Proposed action: Confirm that the Local Board Chair (or her representative) will be available to attend a meeting with Ministers on the land (date to be advised) and speak to wider community opposition related to the proposed development and being shut out of the decision-making process.

3. Rennie Block – IMMEDIATE ACTION NEEDED

SOUL has been advised that the Rennie Block, which was purchased by Manukau City Council to be included in the Otuataua Stonefields Historic Reserve and is adjacent to SHA 62, has been rezoned to 'future urban'. We are deeply concerned about possible development plans. Hon. Aupito William Sio agrees that the Rennie Block needs to be part of the solution to the SHAS62 crisis. We need our Local Board to advocate strongly to Council for this happen.

Proposed action: Address this matter with Auckland Council as a matter of urgency. Advocate for the Rennie Block to become part of the Council's contribution to resolving

the crisis associated with SHA62. Remind the Council of its obligation to honour the original intentions for this land (that it would become part of the Reserve's future).

4. Management of the Otuataua Stonefields Historic Reserve – IMMEDIATE ACTION NEEDED

The Otuataua Stonefields Historic Reserve (the Reserve) is showing significant signs of poor management, including overgrown grass and a plethora of weeds. When problems appear, such as a broken gate, people are advised to contact the Council helpline. Some time ago SOUL discovered that the current management plan for the Reserve was well over a decade old. Also, under Manukau City Council, the Reserve had designated funding but, with the advent of the super city, this allocation was lost and the funds were swallowed up into a consolidated budget. The Council seems unaware that this Reserve is not like other parks across the region. It has special heritage status. We have applied for its status to be upgraded and that decision is pending. The stonefields and archaeological sites will degrade if not properly managed. A 'hands-off' approach is not a proper way to manage an historic reserve.

Proposed action: Address the inadequate management of the Otuataua Stonefields Historic Reserve with Auckland Council and argue strongly for a complete review of the current management policy, plans, operations and budget. The review must include consultation with those who know it best and longest: mana whenua and respected archaeologists Dave Veart and Ian Lawlor, who were part of its original advisory group.

5. Legal action with Heritage New Zealand

Four parties, including SOUL, have initiated legal action in the Environment Court, objecting to the archaeological authority issued by Heritage New Zealand to Fletcher Building allowing it to modify or destroy archaeological sites on the land. Attempts at mediation in January 2018 failed and the matter is now before the Court. This is the final step available in legal action, so we need to urgently progress political discussions.

Proposed action: Advise SOUL how the Board can show support.

6. Funding issues

6.1. Long Term Planning Process

At a meeting last year SOUL was advised by local politicians to put a proposal to the Local Board for a financial contribution towards the purchase of SHA62 as part of the LTP process. But there has been no follow-up and we now seek a status report.

Proposed action: Provide a status report to SOUL on that proposal.

6.2. Airport Shares

At a meeting last year, also attended by the Local Board Chair, Hon Aupito William Sio suggested that Auckland Airport share income should be earmarked for South Auckland initiatives including the preservation of the Ihumātao landscape. He noted that Manukau City had chosen not to divest itself of these shares and intended to use them to support local initiatives, recognising that our communities bear the brunt of the Airport's presence. It is unclear what has happened to the income from these Auckland Airport shares, but this income should be set aside for projects that enhance our South Auckland landscape and grow opportunities for our people/communities. This

income, if ring-fenced, could provide a crucial sustainable funding stream for the ongoing maintenance plan of the Ihumātao landscape.

Proposed action: Clarify with Council what has happened to income from Auckland Airport shares and argue strongly that it be earmarked as a sustainable funding stream for the ongoing protection of the Ihumātao landscape because the airport bears down on it and the new runway will take it and its aircraft noise closer to it.

7. Visitor Needs

The SOUL Campaign has stimulated significant visitor interest in the Otuataua Stonefields Historic Reserve and educational activities at Kaitiaki Village. Council also actively promotes the area to visitors. In the first three months of 2017, over 1000 school students visited the area and were given guided tours by SOUL supporters. Interest continued throughout the year. Four schools have already booked tours for early 2018. In February 2018 a Heritage Rescue Programme film crew also filmed an episode for television, which will draw further attention.

7.1. Toilet facilities – IMMEDIATE ACTION NEEDED

There are no toilet facilities at the main entrance of the Otuataua Stonefields Historic Reserve. A temporary arrangement is urgently required and needs to be properly maintained. A permanent structure would be inappropriate at this time given the current controversy, so we suggest two portable composting toilets.

Proposed action: Address the urgent need for a temporary toilet arrangement and maintenance plan for it.

7.2. Signage and direction finders

The whole Ihumātao landscape is lacking in educative signage and direction finders. This matter pertains not only to the Otuataua Stonefields Historic Reserve but also to the neighbouring maunga and the rare natural wonder known as the Fossil Forest. Also, there are no connections drawn to the relationship of this landscape with the Māngere Mountain/Māngere Mountain Education Centre. There are no direction finders from the airport to lead visitors to the Otuataua Stonefields Historic Reserve. Also, this area is part of the Te Araroa Trail but there is no signage to indicate this or to guide visitors.

Proposed action: Review signage in the area and direction finders, and create a proposal in consultation with mana whenua, SOUL, Māngere Mountain Education Centre, the Airport and other interested parties. A local Board funding allocation will be needed for this project.

In particular, the new sign installed last year at the entrance of the Otuataua Stonefields Historic Reserve is pointing in the wrong direction and confusing visitors. It talks about Otuataua but faces Puketapapa. This sign does not mention other hapū who settled in the area. It overlooks significant heritage information such as the confiscation that drove mana whenua from their lands. Ignoring to mention this event, in particular, gives a "whitewashed" version of what was, in fact, a terribly traumatic period in New Zealand history.

Proposed action: Review the sign's wording and consult more widely to ensure more comprehensive information is provided. Also, reposition the sign so it is facing the maunga it is talking about.

7.3. Education planning and funding

Coupled with the above, is the need for a Local Board funding allocation for education activities at Otuaataua. We are aware of other-related education work underway at the Māngere Mountain Education Centre, which needs to be considered and linked together, as part of long term planning. Because of SOUL's current (unfunded) engagement with visitors, we want to contribute to this future planning. This matter needs proper consideration alongside the future of the land currently threatened by development.

Proposed action: Indicate how the Board will begin to progress this matter.

8. Related matters

8.1. Structure Plan

In 2012 the Environment Court recommended that a Structure Plan be developed for the Ihumātao area and include protections against adverse traffic impacts arising from new developments particularly with respect to the amenities and safety of the local papakainga. Over many years Makaurau Marae has lobbied for traffic safety measures (such as judder bars and chicanes) but without success. The papakainga at Ihumātao is fast becoming exposed to high traffic flow of heavy and light vehicles supporting local industry. A traffic plan is urgently needed to divert heavy vehicles and excessive commercial traffic away from the centre of the papakainga. Traffic slowing/calming measures are also urgently required.

Proposed action: Check the status of this planning work. What has Auckland Council done to enforce the Court's recommendation? Is there a structure plan for the Ihumātao area and if not, why not?

8.2. Oruarangi Awa

In relation to Oruarangi Awa, there is a concept – ma uta ki tai – (from river source to the sea) that is widely evoked in kaitiaki work with rivers by many Māori communities. This holistic framing speaks to the need to think about the health of a waterway at catchment level, which supports the notion of the river/catchment as a living entity and has created the precedent of the Whanganui Awa attaining the status of a legal person. Such an approach properly negotiated with mana whenua and applied to Oruarangi Awa might help to provide new ways of thinking about what is at stake at Ihumātao where the land we are fighting for feeds tributaries to the river, emphasising that land and water cannot be meaningfully separated. Currently there is enormous harm to the river from historic and ongoing abuse. It is wounded and ill, but there is enormous resilience in these systems that mean that different approaches can produce sensational results. The current climate with the new Government provides a moment in which such changes may take root and thrive if the seed is planted by the local community through our political representatives, the Māngere-Ōtāhuhu Local Board.

The river bed of the Oruarangi Awa is in the ownership of Watercare. We understand that the awa bed in the tidal zone will revert to Maori ownership at an unknown date. This zone receives stormwater from Auckland International Airport Limited's development 'The Landing', Sistema area, and SHA62, plus the stormwater from the Airport Oaks, Villa Maria and Pavilion Drive areas.

Given the unfortunate 2013 dye spill into a stormwater drain, we would suggest re-activating the Industrial Pollution Prevention Project (IPPP) to educate industrial workers in these areas. This initiative could be developed in partnership with community volunteers. Also, we are concerned at the ongoing loss of natural wetlands and channels, shrinking the local aquatic habitat, and their partial replacement with swales and constructed ponds. We recognise, and the Board must too, that there are consultation issues creating problems at a local level but an opportunity for meaningful engagement needs to be given to all affected Māori, to express their concerns and interests on these waterway issues.

Proposed action:

Work with mana whenua and the local community to elaborate and institute a 'ma uta ki tai' approach aimed at protecting and restoring the mauri of Orurangi Awa.

Seek a status report from relevant parties (McDonald Assoc./Auckland Council etc) on the development of the Ihumātao Catchment Management Plan.

Ask those responsible to consider reactivating the Industrial Pollution Protection Project, ensuring that business owners on Auckland International Airport Land developments beside Orurangi Road are visited.

Question the need to eliminate natural channels and wetlands, and review instructions for Council maintenance contractors – protocols should preclude clearing vegetation from stream margins.
