Submission re:- Reserve Maintenance 15/02/2018

To Puketapapa Community Board

The reserve in question was once known as the Cross St. Road Reserve. It would now appear to be incorporated with the Parau St. Cycle/Walkway. It is located between Kings Rd. and Princess Ave. The chain of responsibility for grass control is Auckland City then A.T. who contract out to Downers.

The care and maintenance of the grass during 2017 has been substandard to such an extent that a fire hazard came to exist in December 2017. Mr. C. Horne resident at 24 Kings Rd. contacted Auckland Council to be informed that the key to unlock the "anti - hoon" bollards at each entrance to the reserve had been lost which prevents Downers from using a ride-on mower.

Prior to Christmas 2017 the height of the grass and the summer heat in my opinion produced a fire hazard. On the 15/12/2017 I made my concerns known to the Auckland Central Fire Protection and Prevention Officer, Mr. Jason Coffin, by telephone. He investigated my call for help and Informed Council of the situation. Downers sent a man with a hand held petrol driven scrub cutter to spend about four to five hours to knock down the grass. A ride - on mower could have completed the task in less than an hour.

The grass is again in need of cutting. I wonder if the Council has approached a lock-smith to rectify this bizarre state of affairs? There is a very good lock-smith in the Balmoral shopping centre.
