

Maungakiekie-Tāmaki Local Board area



The Maungakiekie-Tāmaki Local Board covers the south-eastern part of the isthmus, including the suburbs of One Tree Hill, Royal Oak, Onehunga, Penrose, Mt Wellington, Panmure and Glen Innes. Bordered by two bodies of water, the Manukau Harbour to the south and the Tāmaki Estuary to the east, Maungakiekie-Tāmaki is home to many outstanding natural features including Kaiahiku (Panmure Basin) and Waipuna (Van Dammes Lagoon). Additionally, there are five significant maunga (volcanic cones) in the board area, including Maungakiekie (One Tree Hill) and Maungarei (Mt Wellington). It also has the large retail areas of Sylvia Park, Onehunga, Royal Oak and Panmure town centres.

Collaboration is going to be major focus for us in the next 3 years. We need to work with others to ensure our area is sufficiently resourced, cared for and safe. We will also prepare for growth with the redevelopment on both sides of the ward as we need to make sure infrastructure is upgraded and developed to deal with the influx of new residents.

We have a lot of opportunity in our ward with Onehunga Transform and the Tāmaki regeneration and we will continue to advocate for the best outcomes for our communities. Looking after the environment and cleaning up our waterways is a constant demand from our communities and is a major feature of this draft plan. What is also important to this board is looking after our communities and we will work to strengthen our community sector to make the most of the Empowered Communities Approach in Council.

Community engagement is another priority for this local board, we have started our term with successful turnouts at public meetings however we will explore other ways to engage as we know that the town hall style one size fits all approach will not achieve our reach to diverse communities.

Each of us has an important part to play - industry, community, Government, residents. We can achieve great things for MaungakiekieTāmaki if we all come together. We need to hear if we have missed something out or if you agree with the priorities in this draft plan so that we can work towards achieving these outcomes and finding the resources to make them happen. This is why it is important for you to submit on this draft plan please.

About local boards

Auckland Council has a unique model of local government in New Zealand, made up of the governing body (the mayor and 20 ward councillors) and 21 local boards. The governing body focuses on Auckland-wide issues while local boards are responsible for decision-making on local issues, activities and services and provide input into regional strategies, policies and plans.


These local issues, activities and services include:

- supporting local arts, culture, events and sport and recreation
- providing grants and partnering with local organisations to deliver community services
- maintaining and upgrading town centres and facilities including parks, libraries and halls
- caring for the environment and preserving heritage.

Local boards also have a role in representing the view of their communities on issues of local importance.

About local board plans

Local board plans are strategic documents that are adopted every three years. Their purpose is to set a direction for the local area that reflects community priorities and preferences. They guide local board activity, funding and investment decisions. They also influence local board input into regional strategies and plans, including the Auckland Plan.



Each local board develops annual work programmes following confirmation of the budget available to them via the annual budget setting process.

Developing our plan

Our plan is comprised of aspirational outcomes, objectives we want to achieve and some key initiatives to carry out. To make this happen will take the efforts of many working together.

We have identified these by considering what we know about our community, what you have told us is important, and where we think we can make the biggest difference.

We are here to listen and act, and value your thoughts and input into the work we do. We have continued to consider feedback from previous terms where there is work still to be done, and acknowledge the members of our community who have told us - and continue to tell us - what is important to them. This plan builds on the successes and lessons we have learned by working with you over the past six years.

Carrying out our plan

Resourcing

We want to do what we can to improve our local board area while being realistic that we cannot do everything with finite resources. This means making the most of what we already have, working with others and acknowledging when we do not have the necessary resources to carry something out.

We believe we can carry out all of the proposed key initiatives in our plan within our existing resources, or there is provision for them in future years of the 2015-2025 10-year budget. By existing resources we mean:

- finances we receive through our revenue sources such as rates and user charges
- our assets such as our community centres and parks
- council staff who are responsible for delivering our annual work programme
- Auckland Transport Local Board Transport Capital Fund allocation
- our time and energy to represent your views on matters of local importance.

In some instances, our role is limited to representing your views on matters of local importance because we do not have the decision-making authority and/or funding to carry it out. When this is the case, we will use our time and energy to influence the relevant decision-maker. We do this by advocating on your behalf and ensuring they are aware of your views and our support for them.

Empowering communities

We seek to empower and enable our communities. This means listening to what you want to achieve, directing council resources towards community aspirations and supporting

diverse communities to have an input into the things they care about and which matter uniquely to them.

We will prioritise activities that are led by the community, encourage and support people from all walks of life to actively participate in their community, and fully use the talents, insights and contributions of our diverse community. We will work with others to enable our communities to achieve their goals.

Working with Māori

Delivering on Auckland Council's commitment to Māori at a local level is a priority for local boards. The council is committed to meeting its responsibilities under Te Tiriti o Waitangi/the Treaty of Waitangi and its broader statutory obligations to Māori.

The Maungakiekie-Tāmaki Local Board values its relationships with mana whenua and mataawaka, and we are looking for new ways to grow and cement these relationships. Many of the aspirations and concerns we have heard from Māori are echoed across the wider community. We want to deliver meaningful outcomes and benefits for all.

Whakaotinga 1: He hapori ngangahau me te tāuteute a Maungakiekie-Tāmaki

Outcome 1: Maungakiekie-Tāmaki is an active and engaged community

We believe that a community is made stronger and a better place for all of its members when we have a shared sense of identity and values, and celebrate our different cultures.

We will encourage individuals to be active citizens, contributing to the benefit of the whole community. We believe an important way of achieving this is to role-model our community values to our children and young people. We must also give our young people opportunities to participate, and prepare them to be the future leaders of our community. We will also look at ways to support new members of the community to become involved and understand the unique culture of our Maungakiekie-Tāmaki community.

We want everyone in our community to be able to come together and participate. We will ensure our community spaces are easy to access and provide opportunities for everyone to take part in the different aspects of community life.

A key role for our board will be developing strong strategic partnerships, with iwi, not-for-profit organisations, funders, industry and other local organisations. We will help connect our community and work with these partners to leverage and create opportunities that benefit us all.

By working together we can achieve much more than any individual or group, and build a thriving community in Maungakiekie-Tāmaki.

Creating opportunities for our young people

We want all of the young people in our area to be engaged in our community. We will focus on creating opportunities for our young people to contribute positively to the community. We will look to develop a partnership programme of youth activities with the community that will target disengaged youth and provide pathways into employment and good citizenship.

We know ensuring our young people can find good, local, jobs is important to you. We want to support the creation of pathways for young people into training and employment. To support this we will talk to our local industry about providing opportunities and continue to develop strategic partnerships with youth providers, community mentors and groups that support youth employment initiatives.

A safe community

You have told us safety is a concern because of crime rates and antisocial behaviour in some areas. Ensuring that everyone in our community feels safe is a priority for our board.

We will have the most impact by encouraging the community to work together. We will build relationships across the community to support this, and continue working with current partners such as Police and community groups to support and build on existing safety programmes.

You have asked us to prioritise taking care of public spaces, as unkempt areas encourage anti-social behaviour. We will ensure our community spaces are well maintained, so we can all take pride in our area. We will also work with the community on initiatives that encourage people to treat the different spaces in our town centres and neighbourhoods with respect.

Local facilities

We will work hard to make sure Maungakiekie-Tāmaki has the places we all need to come together and participate in community events and activities. We will make sure we are listening and understand what our communities need.

We will look for opportunities we can build on in redevelopments that are happening in our local board area.

You have told us that you'd like to be able to use our outdoor spaces to do more sport and fitness activities, and that having places for families to spend time is important. We will look at how we can make the best use of our existing facilities and invest in improvements that meet the needs of our community, prioritising multipurpose facilities that can be shared. We will ensure our local parks and community spaces are maintained to a high standard, and continue to ensure that all development planning looks to make Council facilities family friendly.

Ruapotaka Marae in Glen Innes is a hub of community activity and special to urban Māori and the wider community. It is long overdue for redevelopment and we will work to ensure Council's commitment to complete this is honoured. We pledge to ensure Ruapotaka Marae is given a place of prominence in the reconfiguration of Maybury Reserve.

Whakaotinga 2: He hapori aronui a Maungakiekie-Tāmaki ki tōna taiao

Outcome 2: Maungakiekie-Tāmaki is a community that cares about its environment

We want our community to be able to enjoy our natural environment. Our waterways and harbours should have clean, healthy water. Our area should be free of rubbish and toxins that harm our environment. We will enable our communities to be champions of environmental protection, so that everyone can benefit from and enjoy our beautiful natural environment in years to come.

You have told us addressing environmental issues in our area is very important to you. We will empower residents to take care of our natural environment. We will actively support community groups through education and by providing grants, helping navigate council processes and by advocating on their behalf.

We will take a leadership role to coordinate the many different groups that have an impact on our environment, and foster a collaborative approach across Maungakiekie-Tāmaki.

We will keep the health of our environment and community at the heart of our decision making. We know you are concerned about the weed spraying chemicals used in our parks, so we will look to adopt effective weed management methods that are not detrimental to the health of the people and the environment.

We want to ensure we are supporting initiatives that have an impact. We will monitor environmental activity across our area so we can measure progress and will share this information with you.

We will prepare our community to be ready for a zero waste Auckland by 2040. You have told us you want our town centres waste free. We will look at ways to support this and other waste minimisation initiatives that reduce the amount of waste going to landfill.

We will consider the impact of climate change on our local environment, and support sustainability initiatives. We must think globally and act locally. We will develop a low-carbon plan and promote sustainability by inspiring and educating our community to make choices that reduce carbon emissions. We will work with partners to identify measures needed to adapt to impacts of climate change, such as coastal protection, and storm-water management.

Clean water and beautiful waterways

We want to restore the mauri (life force) of our waterways. The Tāmaki Estuary and Manukau Harbour both have poor water quality, and coastal erosion remains an issue. Our inland waterways are no better, with Omaru Creek and Miami Stream among the most polluted in Auckland.

Many groups impact the health of our waterways, and they must work together to get our waters and the spaces around them healthy, clean and safe. We are committed to bringing people together and facilitating collaborative action to achieve results.

You have told us you want to be able to swim in our waters and have beautiful areas around them to enjoy. We will motivate our community to play a leading role through education and promotion of the many things they can do to help. We will also look for new measures of improvement that are more meaningful and help us identify and celebrate a range of improvements.

We will ensure all local planning considers water sensitive design, coastal protection, and stream restoration and enhancement work.

Whakaotinga 3: Ko Maungakiekie-Tāmaki te tino wāhi nei

Outcome 3: Maungakiekie-Tāmaki is the place to be

Our area has a distinct identity that attracts people from all over Auckland, and beyond, to live, do business, and play.

Our area is growing and changing quickly. There are a significant number of large-scale development projects underway that will bring in many new people and change the landscape of Maungakiekie-Tāmaki. We support development, and the opportunities it brings, but we want to see it done well and in a way that builds on our area's unique character.

We want our suburbs to have well-designed residential developments that are highly sought after places for people to live. We will work to ensure the well-being of current and future residents is planned for by advocating for the inclusion of high-quality infrastructure and services and other features that make our area a great and accessible place to live.

We will focus on where we can make a difference. We recognise there are significant housing and roading developments happening in our area. This includes the East-West Link road, which many of you have told us you are concerned about. We will work hard to make your views heard as these plans are developed and build on the significant opportunities they present to benefit our community.

We will ensure that the community facilities and spaces we already have are not overlooked. We will advocate for them to receive the investment required to ensure they are maintained and enhanced, to attract use and meet needs of our community.

We will focus on leveraging development opportunities and large infrastructure projects to transform our town centres.

We seek to have Onehunga known as a destination suburb with dining and entertainment districts and a transport hub. Its recreation and entertainment offerings set it apart, and present exciting opportunities for future development.

We will leverage development opportunities to give the Panmure town centre its own point of difference and enhance its historic character. We will also look to unlock development opportunities around Panmure transport hubs.

We will work to leverage the planned Tāmaki transformation project to upgrade the Glen Innes town centre and train station. The redevelopment of Ruapotaka Marae complex will be a key part of this work.

Development in our retail districts of Mt Wellington and Sylvia Park present opportunities to enhance visitor experience and attract more people. We will also ensure Riverside, Penrose and Southdown benefit from the redevelopment of the larger town centres.

Maungakiekie-Tāmaki is the economic engine-room of Auckland. Our massive industrial area generates GDP second only to the central business district¹. We will support our business community, encourage investment, and promote our area as an excellent place to do business.

Building relationships with our business community will be a key priority for us. We want to better understand its concerns and interests so we can work together as effectively as possible.

We also have an important role to play in building networks with other organisations across our community, and beyond, to benefit our business community and help it achieve better outcomes. We will also use the tools that are available to us to encourage investment and protect and support local businesses.

Whakaotinga 4: He rite ngā kounga whakahaere ō Maungakiekie-Tāmaki mō tōna whakatupu

Outcome 4: Maungakiekie-Tāmaki has quality infrastructure to match growth

We must ensure that our infrastructure receives the appropriate investment to keep pace with the massive amount of development in our area. We want to ensure the needs of our community are met - now and in the future - and won't compromise the health of our environment or people.

We will plan for the future. We will work with key partners to ensure development plans consider the impact on our area, and ensure our communities' future needs are met.

Keeping up with growth and development

Many infrastructure projects and assets are not directly led or controlled by the board. Our role is to connect, advocate and partner. We will work with developers and organisations such as Watercare, Auckland Transport, NZTA, Kiwirail and Transpower to advocate for the needs of our community, and to raise your concerns.

We will focus on ensuring our community gets as many benefits as possible out of major transformation projects. We will work to minimise the disruption and inconvenience to local residents.

We will be smart negotiators and strong advocates, to central government and the governing body, to address the need for appropriate infrastructure and services to support our fast-growing areas

Better connections across Maungakiekie-Tāmaki

We want to make it easy for people to travel between the many places they want to visit in Maungakiekie-Tāmaki. Building better connections across our area, joining our parks and community facilities, transport hubs, town centres and industrial areas will be a priority.

You have raised a number of concerns with us about roads, transport and connectivity in our area.

We will look for opportunities to influence large-scale road developments to achieve the things you have said are important. In particular, we will advocate for road infrastructure that reduces congestion and improves traffic flow.

Over the next three years we will prioritise the creation of recreational paths for walking and cycling that contribute to better community health and wellbeing. In the longer term, when our area is less affected by development work, we will prioritise and advocate for safe walk- and cycle-ways to travel across our area.

Public transport is well used in our area. We will look at ways to create better public transport options, and support transport hubs that feature bus, train, ferry and car options.

We will continue to advocate to Auckland Transport and the governing body for improved connectivity throughout our town centres, linking business areas with community spaces and transport links.

Financial information

This section is to provide a financial overview of the Maungakiekie-Tāmaki Local Board.

Based on our existing budgets, we believe we can deliver the key initiatives in our draft plan without reducing our existing levels of service or increasing our local revenue sources, such as local targeted rates and fees and charges.

The governing body will be adopting the council's 2018-2028 10-year budget in June 2018. It is important to note that this could change the funding for local boards, including projects currently provided for in the 2015-2025 10-year budget.

Local activities and levels of service

Local board responsibilities, provided for directly in legislation or allocated to boards, are summarised into local activities. These are described in the table below, along with levels of service statements.
