<p><b>Key Move 1: Lay the Foundation</b></p> <p>Nine actions to deliver this Key Move</p>	<p>The nine actions under Key Move 1 are embedded into the three foundational pillars of ACAF.</p>
<p><b>Key Move 2: Enhance, restore and connect our natural environments</b></p> <p>Seven actions</p>	<p><b>Priority 1: Natural Environment</b> Retains the focus on enhancing, restoring and connecting our natural environments but actions have been reviewed for clarity and reduced to six actions to remove duplication.</p>
<p><b>Key Move 3: Make development &amp; infrastructure climate compatible</b></p> <p>Eight actions</p>	<p><b>Priority 2: Built Environment</b> This Priority area contains key actions for a sustainable built environment. 13 actions have now been combined into 10 to address overlap. These are grouped into four main thematic areas:</p> <ul style="list-style-type: none"> <li>• Sustainable growth</li> <li>• Sustainable infrastructure</li> <li>• Sustainable buildings</li> <li>• Sustainable places.</li> </ul>
<p><b>Key Move 4: Transforming existing buildings and places</b></p> <p>Five actions</p>	
<p><b>Key Move 5: Deliver clean, safe and equitable transport options</b></p> <p>Five actions</p>	<p><b>Priority 3: Transport</b> This Priority area still deals with sustainable transport but actions have been split out to eight. This reflects the priority placed on this area through the consultation feedback. The eight action areas are still concerned with:</p> <ul style="list-style-type: none"> <li>• encouraging mode shifts</li> <li>• supporting a transition to low carbon vehicles</li> <li>• supporting an efficient freight system.</li> </ul> <p>Additional actions focus on encouraging behaviour change and ensuring resilient transport infrastructure.</p>
<p><b>Key Move 6: Move to a zero carbon, climate resilient economy</b></p> <p>Seven actions</p>	<p><b>Priority 4: Economy</b> There are now six actions that underpin this Priority area to address repetition. The action areas still maintain a focus on:</p> <ul style="list-style-type: none"> <li>• supporting businesses transition to a low carbon future with increased resilience</li> </ul>

<p><b>Key Move 7: Help Aucklanders become more resilient and reduce their carbon footprint</b></p> <p>Four action areas to achieve this Key Move</p>	<p><b>Priority 5: Community</b></p> <p>This remains at four actions but an additional focus on communication and engagement been adopted from Key Move 1. The intent of the actions remains the same as Key Move 7, which is to:</p> <ul style="list-style-type: none"> <li>support community-based action for low carbon future and to reduce emissions</li> <li>support resilience building at the community level</li> <li>long term management of our coast.</li> </ul>
<p><b>Key Move 8: Te puawaitanga o te tangata</b></p>	<p><b>Priority 6: Te puawaitanga o te tangata</b></p> <p>Updates are in development, but this will remain a priority area</p>
<p><b>Key Move 9: Youth and intergenerational equity</b></p>	<p>This key move has been moved into the foundational pillar. Updates and actions are being finalised by rangatahi.</p>
<p><b>Key Move 10: Shift to decentralized renewable energy</b></p> <p>Four actions</p>	<p><b>Priority 7: Energy</b></p> <p>There are now seven actions that underpin this Priority area. The intent of the actions remains the same, that is:</p> <ul style="list-style-type: none"> <li>to drive innovation in renewable energy sources</li> <li>to build resilience in the energy system.</li> </ul> <p>Additional actions in this Priority area were adopted from the former Key Move 4.</p>
<p><b>Key Move 11: Grow a low-carbon resilient food system</b></p> <p>Six actions</p>	<p><b>Priority 8: Food</b></p> <p>There are now five actions that underpin this Priority area to address repetition. The intent of the key moves remains the same, that is,</p> <ul style="list-style-type: none"> <li>the focus on retaining productive soils</li> <li>reducing food wastage</li> <li>supporting food security.</li> </ul>
