Introduction & Background

Te Koiwi Park is a 6.5 ha informal recreation reserve in Papakura. Its is located on the corner of Hunua Road and Parker Street. The park is flanked on its southern and eastern boundaries by light and heavy industry.

The reserve comprises a gently undulating landform. It is low lying and subject to flooding. Park features include mature stands of mixed exotic and native trees, two flat open spaces for informal play. These open spaces are separated by two large stormwater ponds located towards the centre of the reserve. Car parking and vehicle access is provided off Hunua Road. The park has minimal amenity and low activation.

The northeastern corner of Te koiwi Reserve is leased to the Papakura Marae for marae, community purposes and kaumatua housing. The marae is a key community service provider within Te Koiwi Park with a large number of people using their services daily.

Recent recreation improvements have been carried out at Smiths Avenue Reserve, located a short walk from Te Koiwi Park, which serve the local community for informal recreation. These improvements include basketball courts, a pump track and playspace.

Project Scope

The project scope of this concept plan is to consider the future use and development of the park, to identify long term improvements which meet community needs and guide future decision making and investment.

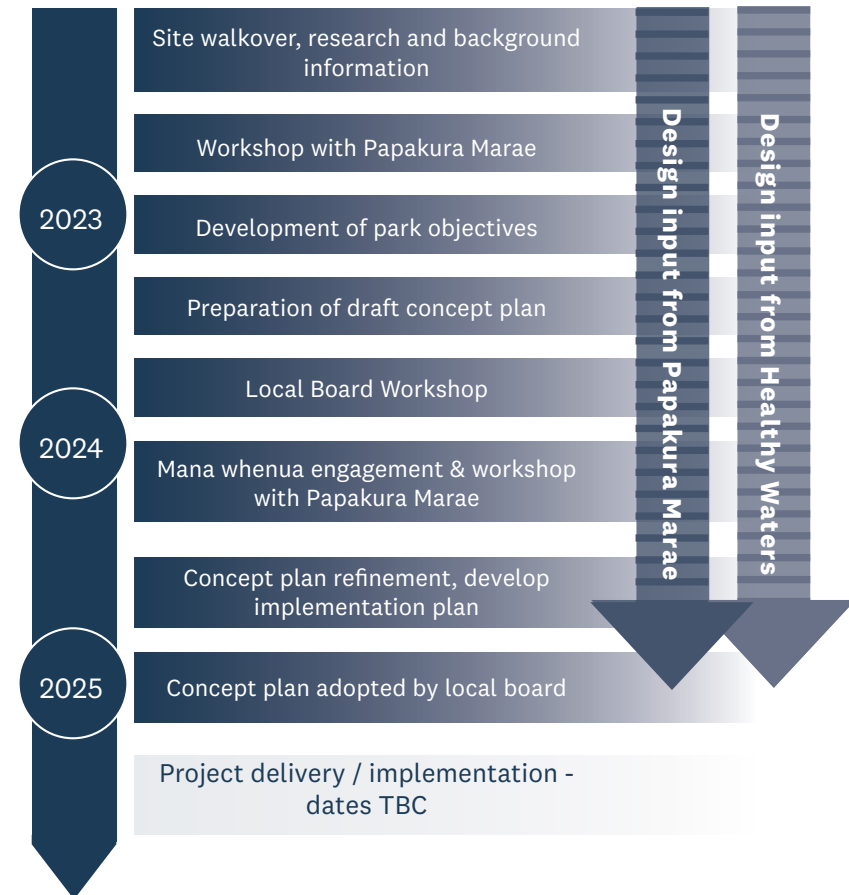
The concept plan will be developed in partnership with Papakura Marae and Healthy Waters.

The concept plan considers;

- cultural heritage, natural environment and recreation opportunities and activation
- access and connections
- the needs of current and future users
- safety / CPTED
- current leaseholders and key users
- synergies with nearby parks.

An implementation plan will be developed in conjunction with the concept plan to facilitate staged delivery.

1.3 Strategic Context

Auckland Unitary Plan

The Auckland Unitary Plan is the principal statutory planning document for Auckland. It describes how Auckland’s natural and physical resources will be managed while enabling growth and development and protecting the things people and communities value.

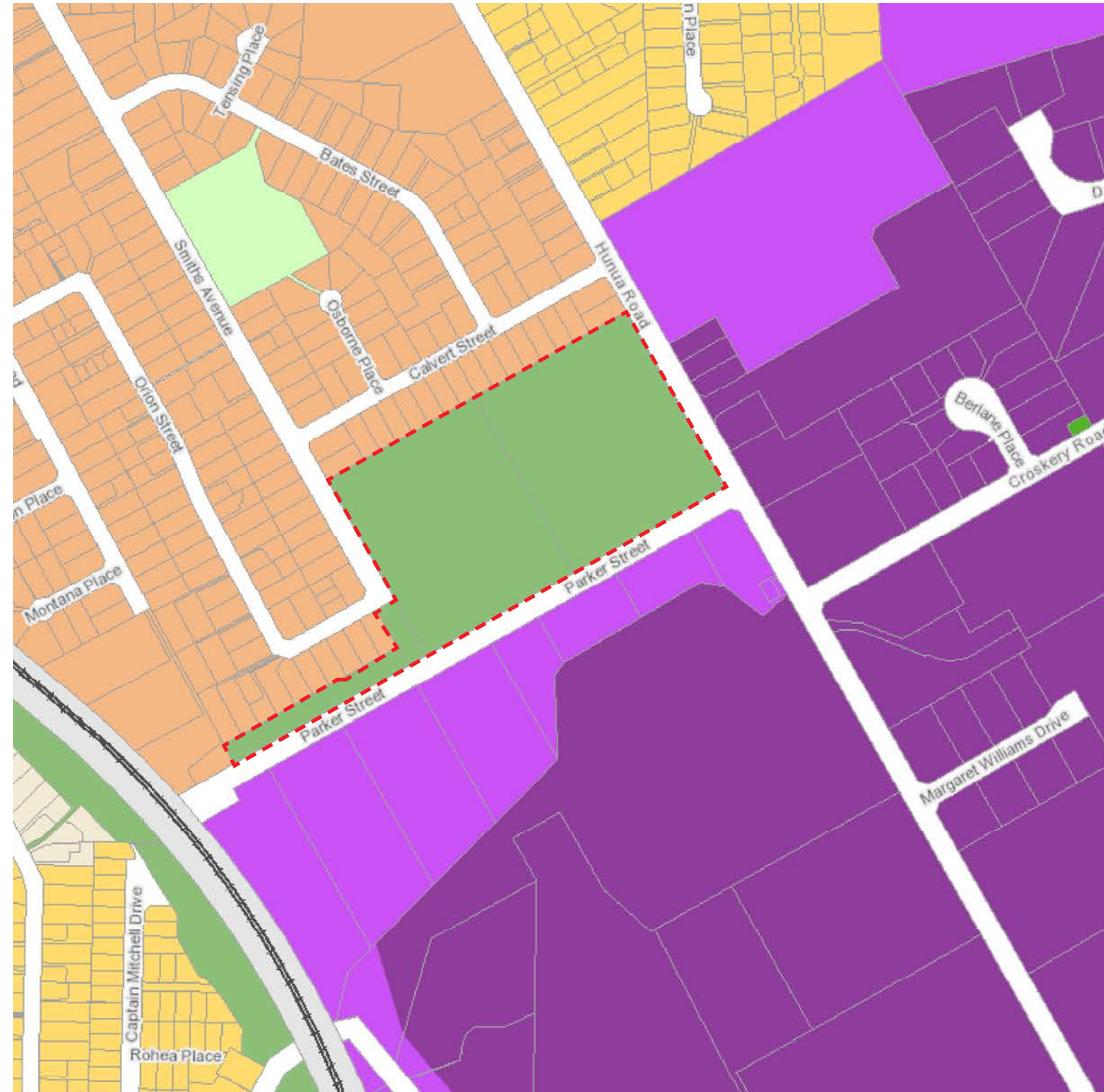
Under the unitary plan, Te Koiwi Park is zoned **Informal Recreation**. These areas are used for a variety of outdoor recreation activity and community uses, such as walking, cycling, relaxing, socialising, picnics, playing and enjoying the environment. They are generally characterised by few buildings and structures to maintain the open space character, amenity values and enable opportunities for a range informal recreational activities.

Objectives

1. The open and spacious character, amenity values and any historic, Mana Whenua, and natural values of the zone are maintained.
2. Informal recreation activities are the predominant use of the zone.
3. Buildings and exclusive-use activities are limited to maintain public use and open space for informal recreation.

Policies

1. Provide for a variety of informal recreation activities, including small-scale community uses and accessory activities.
2. Maintain or enhance the natural character values of open spaces by retaining significant vegetation (where appropriate and practical) and through weed removal, new planting and landscaping.
3. Require development, including new buildings and structures, located near scheduled Sites or Places of Significance to Mana Whenua to recognise the relationship of Mana Whenua to the area.
4. Limit buildings, structures and activities to those necessary to enhance people’s ability to use and enjoy the open space for informal recreation.
5. Locate and design buildings and structures to:
 - complement the open and spacious character, function and amenity values of the zone;
 - maintain public accessibility and minimise areas for exclusive use; and
 - protect any natural or historic heritage values.

- To provide for multiple use of the reserve and maintain adequate access for all users
