# 17 Local board feedback on the recommendations for the Tsunami Resilience Project

Resolution number GBI/2025/84

- a) whakarite / provide the following feedback on the recommendations for your local board area on enhancing tsunami resilience:
  - i) āhukahuka / acknowledge and whakamihi / thank the work of the Tsunami resilience project team and for identifying that the Barrier Islands have "very high" direct vulnerability to tsunami.



- ii) whakaae / agree with the reasoning of this rating for our place which includes all of the coastline, shore and marine areas.
- tuhi tīpoka / note that we also have very high tsunami vulnerability due to the demographic of our community including in particular those that live on the east coast, our aging population and the location of our Marae.
- iv) tuhi tīpoka / note further the vulnerability of critical access routes and low lying key assets including our single main roading network, Shoal Bay, Okupe Whangaparapara & Port FitzRoy wharves and the Claris & Okiwi airports which supply our fuel, food and emergency services.
- v) tono / request to include Whangaparapara and Okupe as additional vulnerable areas currently missing in the resilience planning document.
- vi) With reference to the Aotea / Great Barrier Tsunami Evacuation Zone map (page 13 of the Enhancing Tsunami Resilience in Tāmaki Makaurau Auckland. Recommendations by local board area document as attachment A of the report agenda under separate cover), tono / request to clarify that Port Fitzroy is classed as a yellow land threat zone which is unclear in the map.
- vii) tautoko / support GNS Science findings that the most effective way to increase tsunami resilience is to adopt a multi-channel, inclusive, people-cantered approach that uses both modern technology and community based efforts to ensure that warnings and alerts are understandable and actionable.
- viii) tautoko / support Council's equitable approach to this project noting that many Aucklanders visit coastal areas outside of their local board area and our numbers swell in the summer months.
  - ix) tautoko / support all of the proposed recommendations to keep our community including visitors safe.
  - x) āhukahuka / acknowledge the good work of our local Emergency Response Team and our residents are generally robust and resilient. The local board looks forward to strengthening relationships with Auckland Emergency Management to mitigate tsunami risk for Aotea residents and visitors.
