Te take mō te pūrongo Purpose of the report

1. To update the Ngāti Whātua Ōrākei Reserves Board (reserves board) on the operational work carried out on Takaparawhau and Pourewa by Ngāti Whātua Ōrākei Whai Māia.

Whakarāpopototanga matua **Executive summary**

- Across May and June, Ngāti Whātua Ōrākei Whai Māia teams sustained high performance across operations on Takaparawhau and Pourewa, despite the transition into wetter, colder months.
- 3. The nursery focused on plant health and cleared approximately 20,000 plants in preparation for winter orders and planting days.
- 4. Māra Kai continued to deliver produce to the community, over 400kg harvested, and introduced traditional storage methods for kumara, alongside enhancements to drainage and fertilisation practices.
- 5. Turf operations remained on schedule, with minor weather-related disruptions and the integration of two new kaimahi.
- 6. Volunteer and community participation remained active, with over 200 volunteers supporting events, including a major Matariki planting day where 2,000 native plants were planted.
- Collaborative initiatives with SkyCity, Auckland Council, NIWA and Lion Apiaries reinforced 7. long-term sustainability and matauranga-based research, including a new water filtration project using native rakau.

Ngā tūtohunga Recommendations

That the Ngāti Whātua Ōrākei Reserves Board:

- whakaae / approve the upgrade of the existing informal walkways on Takaparawhau, as a) outlined in the report and plan in Attachment C of the agenda report and to be funded by the applicants of the walkway relocation, to support improved pedestrian connectivity and access, but subject to Ministerial approval of the walkway relocation.
- b) tuhi tīpoka / note the operational updates as detailed in this report.

Operational Update

Financial Implications

- 8. Plant Sales and Fulfilment: Fulfilment of external orders (e.g. SkyCity, Council) supported revenue and reinforced Pourewa's role in urban ecological supply. Plant hire for events provided supplementary income.
- 9. Operational Costs: Winter weather impacted potting schedules, shifting focus toward maintenance and infrastructure work (e.g. drainage installation in mara kai), which may slightly reallocate resource expenditure toward infrastructure resilience.
- 10. Personnel and Training: New kaimahi have been onboarded across teams. Professional development was supported through ITO study enrolments and second-Tuesday study days, with implications for workforce development funding.

- 11. **Apiary Operations**: Hive management was transitioned to Lion Apiaries through a kohabased arrangement, reducing internal resourcing requirements but maintaining operational continuity.
- Research Support: Pourewa's involvement in the NIWA project and AUT student access supports indirect value through reputation, knowledge exchange, and future funding opportunities.

Risk and Mitigation

- 13. **Weather Disruptions**: Wet conditions delayed moving in some soft-ground areas and reduced planting workdays. Teams mitigated this through indoor task reprioritization (e.g. nursery weeding, composting) and adaptive scheduling.
- 14. **Volunteer Drop-off**: Cooler weather led to lower volunteer turnout in may. To mitigate this, stronger communications and relationship-building with key groups (e.g. Te Kāhui Tū Kaha, Mason Clinic) sustained momentum.
- 15. **Crop Losses**: Pukeko damaged carrot crops; mitigation included netting and pinning techniques. Ongoing pest and weed management through traps and organic sprays continues.
- 16. **Resourcing Gaps**: Transitioning kaimahi between teams (e.g. from marae to turf) requires time for role adjustment and training. Support is provided through mentorship and structured induction.
- 17. **Pathway Maintenance Strain**: In the māra, manual path maintenance diverts effort from planting. A review of tools or investment in efficient maintenance solutions is recommended.

Next Steps

- 18. **Planting Programme**: Continue with garden bed rotation (Rua to Toru) and prepare soils with compost and natural fertilisers for spring planting.
- 19. **Volunteer Strategy**: Strengthen communications to increase consistent volunteer participation during winter months; improve volunteer metrics tracking (e.g. hours by area).
- 20. **Infrastructure Planning**: Assess māra kai path maintenance needs and potential for equipment investment. Continue drainage improvements to reduce waterlogging risk.
- 21. **Biodiversity Research**: Progress NIWA collaboration with sampling aligned to maramataka and mātauranga Māori. Support ongoing PhD fieldwork and genomic studies.
- 22. **Workforce Development**: Finalise ITO enrolments and continue fortnightly PD sessions to meet the August qualification milestone.
- 23. **Operational Continuity**: Maintain focus on health and safety standards, adaptive scheduling during winter, and knowledge transfer through kaimahi development across teams.

Health and Safety

- 24. There is nothing to report for May and June 2025.
- 25. Health and Safety remains well embedded across operations at Pourewa and Takaparawhau.

Kaitiaki Services

- 26. There are no new updates.
- 27. Kaitiaki Services continue to play an important role in supporting public safety and fostering respectful use of shared spaces by both Papakāinga residents and the wider community.

Takaparawhau Walkway Upgrade - Approval Sought

- 28. The attached paper seeks the Ngāti Whātua Ōrākei Reserve Board's approval for proposed upgrades to certain informal pedestrian walkways on Takaparawhau, which are part of a broader plan to relocate two pedestrian walkways that currently pass through the Eastcliffe retirement village (Attachment C).
- 29. In March 2025, the Board endorsed the walkway relocation in principle. This proposal involves shifting the access points from Rukutai Street and Aotea Street to new locations at Te Arawa Street and Aotea Street. Auckland Council approved the relocation in June 2025 and has initiated public consultation. However, the final implementation is contingent on Minister of Conservation approval.
- 30. As part of the relocation project, upgrades to existing informal tracks on Takaparawhau are proposed. These improvements aim to enhance pedestrian access and connectivity from the new entry points to the existing concrete path and Atkin Avenue. Importantly, the cost of these upgrades will be covered by the applicants of the walkway relocation.
- 31. Subject to the Minister of Conservation's approval of the Walkway Relocation Proposal, the Board is requested to resolve to approve the upgrade of the existing informal walkways on Takaparawhau, as outlined in the submitted plan.

Projects Report

Te take mō te pūrongo Purpose of the report

1. To update the Ngāti Whātua Ōrākei Reserves Board on key projects managed by the Board. Each project demonstrates the Board's dedication to enhancing the natural and cultural landscapes, while maintaining community engagement and upholding cultural values.

Whakarāpopototanga matua Executive summary

- 2. Progress continues across key Ngāti Whātua Ōrākei Reserves Board projects.
- 3. Pourewa Pathways Phase 4 has entered the construction phase, with bridge works underway and signage design progressing.
- 4. The Takaparawhau Events Ground successfully supported the Matariki 2025 ceremony and is now awaiting final power upgrades.
- 5. Planning for the new Papa Tākaro is advancing, with strong collaboration underway with the Tūpuna Maunga Authority.
- 6. At Pourewa, the Mahi Toi carving facility is being set up, and a funding request for the carving work is being prepared.
- 7. Takaparawhau Cliff Stabilisation urgent investigations are now complete, with immediate drainage improvements planned to address environmental impacts. The Board approved the project as an urgent matter in November 2024. Management now seek confirmation of the \$150,000 budget.
- 8. Meanwhile, Pourewa Accessibility Improvements are ready to commence construction following a successful procurement process.
- 9. All projects remain within budget and are tracking toward their respective milestones.
- 10. Management seeks Board approval for payment of Year 1 funds to deliver Ko Te Pūkāki: 2040, a long-term regeneration project at Takaparawhau and Pourewa. Year 1 includes native planting, invasive species removal, and establishing a Kaitiaki Whenua team. The work supports climate resilience, mātauranga, and whānau and community reconnection with the whenua.

Ngā tūtohunga Recommendations

That the Ngāti Whātua Ōrākei Reserves Board:

- whakaae / approve \$150,000 as the confirmed budget for the Takaparawhau Cliff Stabilisation Project exploratory works (as set out in the report to the Board of 11 November 2024).
- d) tuhi tīpoka / note the Ōkahu Urupā Flood Protection project update provided by Ngāti Whātua Ōrākei.
- e) tuhi tīpoka / note the Matariki 2025 Activation Project update and that the project was successfully completed within the allocated Long Term Plan budget of \$50,000 (approved under delegation).
- f) tuhi tīpoka / note the Minister of Conservation has approved the Combined Reserve Management Plan for the Whenua Rangatira and Pourewa which is now in operation.

Project Update

Financial Implications

- 11. This section outlines the current financial performance of each project, including budgeted versus actual costs, projected final expenditures, and any significant variances or funding implications.
 - **Pourewa Pathways Phase 4**: Budget \$350,000 | Spent: \$8,385. The project remains well within budget, including the addition of a third bridge.
 - **Takaparawhau Events Ground**: Budget \$748,000 | Spent: \$710,302. Slight budget increase expected due to high utility connection costs.
 - Takaparawhau Papa Tākaro: Budget \$225,000 | Spent: \$0. Costs will be incurred once design consultants are engaged.
 - **Pourewa Mahi Toi**: Budget \$250,000 | Spent: \$15,157. Spending to increase as carving commences post funding approval.
 - Takaparawhau Cliff Stabilisation: Budget indicative costs \$150,000 | Spent: \$91,981.
 A minor delay in final deliverables, with no change to the estimated budget forecast.
 Confirmation of the \$150,000 budget is now sought.
 - **Pourewa Accessibility Improvements**: Budget \$200,000 | Spent: \$1,398. Construction to begin shortly, remaining on budget.

Risk and Mitigation

12. The table below outlines the key risks identified across current projects and the mitigation measures in place to address them.

- Commence community and whānau engagement

Pourewa Mahi Toi

- Complete setup of carving centre
- Secure rākau and submit funding request for carving

Cliff Stabilisation

- Host second wānanga in August
- Finalise Management Action Plan and begin intervention work

Pourewa Accessibility Improvements

- Begin concrete pathway and stormwater construction
- Target September 2025 completion


Project Funding Requests

Ko Te Pūkākī: 2040 - Year 1 Funding Request

- 14. This project plan seeks approval from the Ngāti Whātua Ōrākei Reserves Board (NWORB) for Year 1 funding of the *Ko Te Pūkākī*: 2040 programme approved by the Board in March 2025. The initiative is a long-term, brown-green infrastructure capital project aimed at regenerating the natural and cultural ecologies of Takaparawhau and Pourewa.
- 15. The Year 1 plan includes planting 9,400 native plants, removing invasive species, establishing a full-time team of five Kaitiaki Whenua, and using a digital platform for real-time task tracking and reporting.
- 16. The work is grounded in Ngāti Whātua Ōrākei regenerative principles (*ngā mātāpono whakaora*), integrating tikanga, mātauranga, and adaptive environmental management over a five-year period. The activities will contribute to climate resilience, carbon sequestration, community engagement, and the revitalisation of the whenua and wai.
- 17. Management recommends that the board approve the payment of Year 1 funds to enable the carrying out of the scheduled works in FY 2025/26.

Takaparawhau Cliff Stabilisation – Funding Request

18. Given urgent circumstances, the Board have previously approved the Takaparawhau cliff stabilisation exploratory work and the reprioritisation of the long term plan budget for the work (11 November 2024 hui, resolution NGA/2024/27). In November 2024 Management proposed an indicative budget of \$150,000 and given the urgency of the matter commenced works. For absolute transparency, Management now seek confirmation of this funding request to cover the exploratory work.



- 19. In the period since the hui of November 2024 Management have confirmed quotations and budget requirements for the exploratory work. Management have also liaised with the Auckland Council teams who have already undertaken cliff stablisation work within the same region to understand any lessons learned by Auckland Council staff and to promote efficiencies while budgeting for any future works to be brought to the Board.
- 20. Project Update For Information and Oversight

Ökahu Urupā Flood Protection Project Update from Ngāti Whātua Ōrākei

- 21. This report provided by management of Ngāti Whātua Ōrākei provides an update on the Ōkahu Urupā Flood Protection project. While this project is funded by Ngāti Whātua Ōrākei Trust, it is included for transparency and coordination due to its location within the Ōkahu Reserve.
- 22. The primary objective is to strengthen flood protection at the existing urupā, with early work focused on gathering and analysing historical drainage reports, liaising with Auckland Council and Healthy Waters, and exploring engineering options such as perimeter wall reinforcement, drainage upgrades, and protection of the whare karakia.
- 23. In parallel, a separate workstream is underway to research **tūpāpaku practices** and their historical, cultural, and environmental context to inform **long-term urupā planning**.
- 24. **Next steps** include engaging with whānau, aligning efforts with adjacent NWORB projects (like awa restoration), and refining design options with engineering input.

Matariki 2025 Activation Project

- 25. The Matariki 2025 Activation Project was successfully delivered on 20 June 2025 at Takaparawhau. The event, attended by approximately 1,700 people, featured a dawn karakia and hautapu ceremony, wānanga, shared kai, and cultural storytelling. It was led by Ngāti Whātua Ōrākei cultural practitioners and promoted mātauranga Māori while fostering whānau and community engagement.
- 26. All planned deliverables were achieved, including wide promotion through digital and traditional media, contributing to a strong public presence. The upgraded whenua enabled a safe and mana-enhancing experience. There were no issues or risks reported, and no changes to the plan were made. Post-event activities include collecting feedback and archiving content for future use. The funding for this project was approved under delegation by staff and within the budget allocated for the event.

Combined Reserve Management Plan for the Whenua Rangatira and Pourewa

27. The Minister of Conservation has now approved the Combined Reserve Management Plan for the Whenua Rangatira and Pourewa (Attachment J). This Reserve Management Plan is now formally operative.

Financial Update as at 30 June 2025

Te take mō te pūrongo Purpose of the report

1. To provide Ngāti Whātua Ōrākei Reserves Board an update on financial performance as at 30 June 2025.

Whakarāpopototanga matua Executive summary

- 2. Net operating expenditure (opex) as at end of June 2025 was \$1.66m and was about \$200k under budget, as shown in the finance summary table below.
- 3. Funding agreements for maintenance, management support, kaitiaki and nursery staffing were paid in the month of August 2024. This mostly covers all the operational expenses for FY25.
- 4. Management plan budget of \$102k was carried forward from last year. There is also about \$23k of unallocated expenses that was carried forward from last year.
- 5. Consequential opex of \$48k in the budget to cover for any unplanned expense during the financial year was not used.
- 6. Capital expenditure for FY25 was revised and approved by the reserves board at the open hui on 12 May 2025. This was based on the Ko Te Pukaki strategy approved during the financial year which resulted in the revised 2024-2034 capex long term plan.
